

Agency Updates

2024 Virginia Department of Forestry Calendars

The 2024 calendars feature invasive species (plants and insects) in Virginia. The annual DOF calendars are one of our most visible outreach tools and serve as a great educational gift for landowners, loggers, local officials, cooperators and the public. They also provide a convenient "reason" to touch base with a partner or customer.

There will always be faithful folks that will come looking for them, but the calendars are intended as agency educational outreach tools for DOF staff to hand out and deliver. There is space on the back cover for staff to add a label or business card with contact information. This year, 10,000 calendars were printed, with the majority being distributed to the field. Albemarle High Schoolers Learn about Forest Health

Forest Health Program Manager Lori Chamberlin and Forest Health Specialist Katlin Mooneyham gave a guest lecture to the forestry class at the Miller School of Albemarle on Nov. 14. The high school students are learning about all aspects of forestry, and the forest health presentation focused on various forest health monitoring activities and common invasive pests in Virginia.

Hardwood Assessment Tool Used at Pocahontas State Park

On Nov. 20, State Forest Forester **Dennis Gaston**, Hardwood Initiative Coordinator **Joe Rossetti** joined Virginia Department of Conservation and Recreation specialists to perform a stand assessment on a 128-acre stand at Pocahontas State Park in Chesterfield County. The group used the Hardwood Assessment Tool (HAT) on a loblolly pine stand. While not the original purpose for the HAT, DOF will use it to help DCR transition the stand to an oak-hickory forest. This will be the first HAT demonstration area on a state park and its first use converting from pine to hardwood, a topic DOF foresters get asked about by landowners on a regular basis.

New NRCS Forest Farming Practice Available to Landowners

The Virginia Natural Resources and Conservation Service (NRCS) is adding a new practice to their suite of practices available to landowners in the Environmental Quality Incentive Program (EQIP). The new practice is **Code #379 - Forest Farming**, and the practice standard can be found in the NRCS <u>electronic Field Office</u> <u>Technical Guide (eFOTG)</u>, under Section 4 – Practice Standards and Supporting Documents. Forest Farming is defined as managing or establishing stands of trees or shrubs in coordination with the management and/or cultivation of understory plants and nontimber forest products.
