News You Can Use

FY2023 Reforestation of Timberlands Program

- The FY2023 RT Program has been created in IFRIS and can be used to develop new landowner agreements for the FY2023 Program year that begins on July 1, 2022. HOWEVER, it is important to complete the final paperwork for the FY2022 Program year before going too deeply into next year's projects. The FY2023 budget has not been finalized yet, so Regional allocations have not been made at this time. In the FY2023 RT Program year, there are several changes to the prescription rates that are noteworthy:
 - The site preparation, herbicide prescriptions, hardwood only, and pine and hardwood, have been split by the application method aerial and ground so now there are two prescriptions for each herbicide site preparation prescription.
 - The incentive rates have also increased slightly for these prescriptions to help offset the increase in herbicide prices.
 - The prescribed burning rate has decreased slightly to better match the costs of the practice.
 - These changes will be effective for the FY2023 RT Program and cannot be changed during the program year.
- On October 1, 2021, the IFRIS accomplishment codes were updated to help simplify accomplishment reporting. However, due to the fact that several of the accomplishments were being used in RT landowner agreements, a solution was reached to add an extension "(CS RT22 Only)" to the code that was being used in the RT Program. Once the FY2022 RT Program ends, on June 30, 2022, those codes with that extension will be removed from IFRIS. Therefore, as new accomplishments are being planned in IFRIS for the FY2023 RT Program, foresters should use the standard accomplishment codes, without the extension. Emerald Ash Borer Treatment Cost-Share

Enrollment for the VDOF Emerald Ash Borer Cost-Share Program opens April 20. This program provides financial assistance for the treatment of ash trees to protect them from the emerald ash borer. Only landowners in VDOF's Eastern Region are eligible to apply, but organizations statewide may apply. Last Week

State Forester

- VDOF sponsored the Environment Virginia Symposium at VMI and had a range of employees attend and make presentations. Rob Farrell participated in the panel discussion for the keynote session, along with the new directors of DEQ and DCR. Former State Forester and Secretary Bettina Ring was honored with the annual Erchul Environmental Leadership Award for her work in fostering collaboration on behalf of the environment in Virginia.
- Also at the 2022 Environment Virginia Conference, Harrisonburg's Department of Public Works was
 presented the Governor's Gold Medal Award for Environmental Excellence for its Urban ForestryUrban Wood program. These two programs are collectively supported by the VDOF's Urban &
 Community Forestry and Urban Wood teams, which provide technical assistance for program
 development, engaging the municipality and private-sector businesses.
- The popular WAVY TV 10 feature "Hampton Roads Show" highlighted the agency's efforts to promote critical habitats by using prescribed fire. Wildfire Response

- Rain has finally subdued the past week's extremely busy wildfire activity across the state. Over the
 past week VDOF staff fought 55 wildfires for a total of 2358 acres. VDOF has responded to fires in
 almost 30 counties all across the state, the largest being a 1300-acre fire in Lee County,
- With most of the significant fire activity concentrated in the southwestern portion of the state, VDOF activated our readiness plan and moved 16 staff members from the Eastern and Central regions to the southwest portion of the Western region.
- At least two fires resulted in serious injury and significant loss of property. Two people were injured while trying to contain an escaped fire in Pulaski County. In Campbell County, a home and large shop building were lost due to a wildfire that was accidently started on the same property.

Forestland Conservation

- Lara Johnson (urban & community forestry [U&CF] program manager) presented to the new Culpeper Tree Stewards group about environmental factors that affect trees.
- Molly O'Liddy (U&CF partnership coordinator), Meghan Mulroy-Goldman, and Kendall Topping (community forestry specialists) attended the City of Virginia Beach's 42nd annual Arbor Day celebration. A redbud tree was planted at the historic Lynnhaven house to mark the occasion.

Forest Resource Management

On March 29, John Colligan (chief of administration), Jeremey Falkenau (senior area forester), and Dean Cumbia (director of forest resource management) visited several forest management project sites on private lands and Sandy Point State Forest in King William County. The sites included both pine and hardwood sites that have been actively managed or with planned practices. These sites provided an excellent setting for discussion regarding overall management practices, landowner assistance, and program delivery. Thanks to Dave Slack (area forester) and Dennis Gaston (forest management specialist) for assistance with preparation and background information.

- On March 29, Katlin DeWitt (forest health specialist), Lori Chamberlin (forest health program manager), and Amanda Conrad (forest health technician) met with Shannon Lewis (forest management specialist) and Devin Bily (plant pathologist with Virginia Department of Agriculture and Consumer Services[VDACS]) at Cumberland State Forest (CSF) to assess an aging pine stand with thin crowns and diminished productivity. There was no evidence of bark beetle activity, so soil, root, and fungal fruiting body samples were collected and sent back to Richmond for analysis. Additionally, forest health staff placed southern pine beetle traps in CSF as well as at Prince Edward State Forest.
- On March 30, Matthew Coleman (senior area forester) and Dean Cumbia met with a forest landowner in Spotsylvania County to assess effects of heavy snow on forest stands.
- On March 31, Joe Rossetti (hardwood habitat coordinator), Mike Womack (forest management specialist), and Dean Cumbia led a pre-bid meeting for potential hardwood contractors at the Appomattox-Buckingham State Forest Headquarters. Bids are being solicited to conduct crop tree release on stands in three different state forests. Joe provided an overview of the practice and work to be completed, followed by a field visit to one of the sites.
- Katlin DeWitt attended a virtual training session to be an EDDMapS verifier. EDDMapS is an online database for documenting invasive species distribution. The public can report occurrences of invasive plants, insects, and other animal species. All entries are verified by knowledgeable naturalists before points are confirmed on the map.
- VDOF forest health liaisons and other volunteers conducted visual surveys for spotted lanternfly in February and March. Surveys were conducted in high-risk areas such as parking lots, rest areas, and popular hiking trails. A total of 73 surveys were conducted. Thank you to everyone involved!

Agency Lands

- The Sussex nursery has finished lifting this year's loblolly pine crop. The nursery lifted and graded 23,272,000 loblolly seedlings.
- The Augusta Forestry Center (AFC) field crew continues to lift and grade trees. The office has taken in 1950 orders worth \$631,211.

State Forest

- State Forest staff finished painting all boundary lines, and installing kiosks, signage, and gates at Charlotte State Forest, in preparation for opening the state forest for public use.
- Tree planting has been completed on State Forest and State-Owned Lands.

State-Owned Lands

Staff completed the cruising and harvest layout for the Department of Veteran Services Cemetery
property near Amelia, and for the Virginia Department of Transportation Meadow Tract complex in
Henrico.

Central Region

- Ashley Mock (bay watershed specialist) and Matt Wolanski (senior area forester) co-led a volunteer riparian buffer planting with the Friends of the North Fork of the Shenandoah River. The project involved the planting of 360 hardwoods, furnished with tree shelters, stakes, and bird nets, across nearly two acres of floodplain. The funds for the project came from the Mountains to Bay buffer program, and nearly 50 volunteers completed the planting.
- Amy Bigger (Area Forester) participated in the Central of Lunenburg Career Expo, attended by about 950 students in 5th through 12th grades. The table was set up with various forestry tools and

 Adam Smith, Kinner Ingram (senior area foresters) Chad Briggs (area technician), Chris McClelland, Alex Hernández, BJ Butler, Tom Snoddy, Connor Goolsby, and Mike Aherron (area foresters) were deployed as a part of the Central Region Green Task Force to the Western Region Complex Fires. The Complex included fires in Russell, Tazewell, Buchanan, Lee, and Scott counties. Favorable weather conditions have helped staff get full containment and burnout operations completed while remaining available for new fires and high priority needs.
