engaged Weyerhaeuser and VDOF were and how well we work together. This speaks highly to both your team, Kevin and the others, and your support for them.



## Telework Policy Update

- On March 23, the Telework Policy was updated by the Department of Human Resource Management (DHRM) in Richmond. The primary changes include:
  - 1. Updating Cardinal with 2023 Dates
  - 2. Simplifying the annual renewal process
  - 3. Removing the requirement for Cabinet-level approval unless the Telework Agreement is new or modified and includes more than one-day of requested remote work.
- ▶ Based on the current policy, there is no need for employees to submit a new Telework Agreement unless there are changes to their current approved Agreement. The renewal process can be a verbal conversation between the employee and his/her supervisor, and if no changes are made, the only action needed will be an update in Cardinal to show the new approved 12-month period. Cardinal now has the capability to provide a report of all agency employees with an approved Telework Agreement, to include number of days by employee. Once all Telework dates have been updated on 7/1/23, this report will be provided to the State Forester for his review and approval.
- Based on the updated policy, there is no need for each employee to resubmit a Telework Agreement as part of the annual renewal process.

## Sonar Detectors for the Northern Long-Eared Bat

♦ DOF staff met with Virginia Department of Wildlife Resources (DWR) representatives to discuss potential harvesting impacts and limitations due to the endangered Northern Long-Eared Bat. In cooperation with DWR, two sonar detectors were placed in Cumberland State Forest as part of a long-range North American bat survey. Over the next two months, the detectors will be moved to other state forests to help identify additional potential habitats.

## Board of Trustees Meeting for the Virginia Land Conservation Foundation

DOF Forestland Conservation Program staff attended the Board of Trustees meeting for the Virginia Land Conservation Foundation (VLCF). At the request of the Board, DOF and other participating agencies presented on funding opportunities available to leverage VLCF funds to complete land conservation projects, which for DOF includes the U.S. Forest Service's Forest Legacy and Urban and Community Forestry programs. Other agencies covered a range of funding opportunities such as the federal Land and Water Conservation Fund administered by the Virginia Department of Conservation and Recreation, and the Preservation Trust Fund administered by Virginia Outdoors Foundation. At the meeting, the Board also approved the opening of the FY2024 VLCF grant round that totals over \$16 million (including \$2.4 million for projects in the forest preservation category.) Applications are due in August.

## "All About Oaks" at Northern Virginia Urban Forest Roundtable

♦ DOF Assistant State Forester Terry Lasher participated in the Northern Virginia Urban Forest Roundtable event "All About Oaks." The successful event included approximately 100 urban forestry professionals. The group enjoyed multiple morning sessions on the regeneration, diagnosis and management of oak species. The afternoon session was held outdoors at the Conway Robinson State Forest in Prince William County. A plant health care truck was brought in to demonstrate optional management strategies for yard oaks and U.S. Forest Service staff led a tour to discuss oak regeneration in the state forest.

## Inflation Reduction Act Funding Deadline

The Inflation Reduction Act public-facing portal closed for applications on June 4. DOF submitted a request with the theme of assisting smaller Virginia communities with urban forestry projects. Virginia municipalities and urban and community forestry partners also worked with DOF staff to submit applications and the agency provided support letters to partners applying for funding independently. This historic funding will provide foundational support for related activities across the Commonwealth.

## Invasive Emerald Ash Borer Treatment in Shenandoah Valley

DOF's Forest health staff treated eight ash trees at McCormick Farm's Shenandoah Valley Agricultural Research and Extension Center. The chemical treatment protects trees threatened by the invasive emerald ash borer for approximately three years. A representative from Rainbow Ecoscience company demonstrated new injection equipment for treating ash trees in the future.

## **Forest Management**

Amanda Conrad (forest health technician) conducted emerging pest surveys for beech leaf disease (BLD) in several counties around central Virginia. This is part of an ongoing effort to monitor and track the spread of pests and diseases that are yet to be seen statewide. All survey locations were negative for BLD presence but will continue to be monitored in the future.

- Forest Health staff are participating in summer surveys for the elm zigzag sawfly (EZS). This survey program was initiated by the U. S. Forest Service and North Carolina State University to learn more about the distribution and impacts of EZS, an emerging pest that feeds on all species of elm trees in Virginia. Selected elm trees will be monitored monthly to see if EZS is present, and the severity of damage it causes. The feeding pattern of the pest is a very distinctive "zig-zag" starting from the edge of elm leaves and working inwards. - DOF has received several reports of spongy moth defoliation and there will be further investigation.
