Forest Management Academy -- September 11-15

The annual Forest Management Academy will be held on Sept. 11-15 at Sweet Briar College in Amherst. This year's Academy will feature three training tracks including those geared at newer non-field employees, newer field employees and experienced field employees. Track 1 and 2 attendees will gather on Monday afternoon to learn more about DOF, how we conduct our work, and tips on customer service and sales. On Tuesday, Track 1 employees will have a field tour to experience forestry in Virginia. Track 2 will focus on skills essential for success like field data gathering, planning and tree planting. Track 3 employees will cover topics including forest *land*, carbon, and invasive species management. All tracks will include a combination of classroom and field instruction. Talk to your supervisor for guidance on the track that's best for you, and how to register. **Registration is open through July 31.**


Last Week

Virginia Loggers Association Quarterly Meeting and Site Visits

The Virginia Loggers Association (VLA) arranged two days of site visits for State Forester **Rob Farrell** to meet with loggers and visit active timber harvests supplying woody biomass to the three Dominion biomass energy facilities. The sites demonstrated the range of timber harvests that normally provide residual material for biomass. Farrell also attended the VLA quarterly board meeting where the loggers helped develop a survey for all loggers who supply the Dominion biomass facilities. Survey responses will provide information for the carbon life cycle analysis study currently under way.

Agroforestry Training

Forest Management Coordinator **Todd Groh** recently attended the "Agroforestry Training for Natural Resource Professionals, Forest Farming 101 – Fundamentals." The session was held on July 20 at Kentland Farms near Blacksburg, which serves as Virginia Tech's working farm and forest. Sponsored by the Appalachian Sustainable Development organization, nearly 20 professionals, primarily from the Natural Resources and Conservation Service, attended. "Forest farming" is a unique approach to land management which combines management practices of conventional forestry with small-scale farming of wood grown herbs and other plants to help provide intermediate and sustainable income. Instruction included determining the best sites for forest farming as well as details on the most common forest farming crops (ramps, black cohosh, goldenseal and ginseng).



Two additional agroforestry training sessions will be held later this year, <u>Silvopasture on Aug. 15</u> in Blackstone and <u>Alley Cropping on Sept. 21</u> in Catawba. The guidebook (pictured) used in the training is available through <u>https://www.appalachianforestfarmers.org/intro</u>.

DOF Helps Nansemond Indian Nation with Sugar Maple Salvage

On July 17, Community Forester **Kendall Topping**, District Forester **Luke Marcek** and intern **Evan Ruland** assisted the Nansemond Indian Nation to preserve the southern sugar maple population in Mattanock Town in Suffolk. This area is the only known area in southern Virginia to have a



southern sugar maple population, making it of cultural importance to the Nansemond Indian Nation. The current area will be treated for Chinese privet and if left, the maples would be killed in the removal process. Over 150 sugar maple seedlings were salvaged by volunteers and will be given to tribe members, schools and nonprofit organizations. During the project, Kendall spoke with a reporter from *The Virginian-Pilot* about the importance of biodiversity and riparian buffers.

WTKR Features Positive Impacts of Trees

in Hampton Roads
