#### Chesapeake Bay Meeting

DOF Watershed Program staff attended a recent Chesapeake Bay funding meeting with Secretary of Agriculture and Forestry Matt Lohr, Secretary of Natural and Historic Resources Travis Voyles, Director of the Office of Regulatory Management Andrew Wheeler, and other state agency representatives. The objective of the meeting is to increase awareness of various funding opportunities available to landowners for project implementation regarding the Commonwealth's WIP III goals. DOF is coordinating with the Virginia Soil and Water District to discuss next steps.





#### **Conservation Easement 206**

DOF established its 206<sup>th</sup> conservation easement on the 1,000-acre Black Walnut property in Charlotte County. The easement conserves 932 acres of working forests, 90% of which are considered high Forest Conservation Value. The area includes nearly three miles of frontage on the Roanoke River.

#### Wavyleaf on State Lands

Invasive Species Specialist **Lindsay Caplan** has been surveying state land for wavyleaf grass, an invasive plant that is included on Virginia's Noxious Weed List to identify and control its spread. On Aug. 7, she met with Virginia Department of Wildlife Resource staff at Thompson Wildlife Management Area in Fauquier County where a wavyleaf population was found and treated last year (no plants were located during this year's survey efforts). Lindsay also surveyed for, located and treated several populations of wavyleaf grass on Conway Robinson State Forest and Whitney State Forest in Northern Virginia. At Conway Robinson, treatment efforts were assisted by staff from the nearby Manassas National Battlefield Park. The wavyleaf was beginning to seed, so the plants were cleared from the trails to prevent forest visitors from spreading it further, and more extensive treatments will take place next year.

### **Emerald Ash Borer Treatment at Cumberland State Forest**

Forest Health Technician **Amanda Conrad** recently treated a large ash tree at Cumberland State Forest to protect it from the Emerald Ash Borer. The tree is on the edge of a harvested area. One of the goals of this treatment was to keep a seed source of ash on the forested landscape for the long term. While the tree is in decline, and we will also observe if treatment can help in recovery of trees already affected.

#### **4H Forestry Day Camp**

Forest Technician **Shane Burgess**, Area Forester **Levi White**, and Area Forester **Tom Snoddy** spoke to approximately 20 children at Bear Creek Lake State Park in Cumberland County as part of a day camp with the local 4H office. Students learned forest management as well as firefighting and fire prevention. As usual, the bulldozer was a big hit.

#### Louisa County National Night Out

Area Forester **Cameron Lipscomb** attended Louisa County National Night Out. DOF's display included the equipment that wildland firefighters use. Cameron spoke to a total of 124 youth and adults about fire prevention and forestry programs that DOF offers to landowners.

## Amherst County Night Out

Area Forester **Garrett Evans** and Forest Technician **T.C. Orman** attended the Amherst County Night Out. This annual event provides the public with an opportunity to meet local and state law enforcement officers, learn the duties and responsibilities of each agency, and view emergency equipment and demonstrations. DOF employees spoke with members of the community about services provided by DOF, benefits of healthy forests, timber sale planning, outdoor fire laws and safe debris burning. DOF brought a transport and bulldozer to help illustrate how wildfires are contained and managed by staff and volunteer fire companies.
