Application to camp is a two-step process. To apply:

- ◆ The student must complete sections 1-3.
- ◆ A nominator not related to the student must complete section 4 and submit the form by mail, email, or fax by April 26.
- ◆ Incomplete applications will not be accepted.

Applications will be reviewed as they are received, and students will be notified of acceptance. All students accepted to camp will receive a substantial scholarship and pay only \$95 to attend.
